Weights: Three-Year-Olds: 119 lbs; Older 124 lbs: Non winners of \$18,000 twice in 2018 allowed 2lbs.; \$18,000 in 2018, 4 lbs.; \$15,000 in 2018, 6 lbs; (Maiden and Claiming Races not considered in Allowances). Starters to be named through the entry box by the usual time of closing. High Weights Preferred. Total earnings in 2017-2018 will be used in determining the order of horses with equal weights on the scale. Earnings will be determined according to statistics provided by Equibase. This race will be limited to Twelve 10 starters. The guaranteed money and OBF funds to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. A suitable award will be presented to the winning owner.
