Total earnings will be used in determining the order of preference of horses with equal weights on the scale. Earnings will be determined according to statistics provided by Equibase. This race will be limited to 12 starters. The guaranteed money to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Should the winner be a graduate of the OKC Summer Sale, he or she will receive a \$25,000 bonus. A suitable award will be presented to the winning owner.
