High Weights Preferred, Then Highest Lifetime Earnings of horses with equal weights. Earnings will be determined according to statistics provided by Equibase. The guaranteed money and OBF funds to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. A suitable award will be presented to the winning owner.
