Starters to be named through the entry box by the usual time of closing. Weights: Three-year-olds 119 lbs. Older 124 lbs. Non-winners of a Sweepstakes in 2020 allowed 2 lbs. \$30,000 at a mile or over twice in 2020, 4 lbs. \$30,000 at a mile or over in 2020, 6 lbs. (Maiden, Claiming, Starter races not considered in Allowances). High weights preferred. Preference of horses assigned equal weights to be determined by lifetime earnings.. Earnings will be determined according to statistics provided by Equibase. This race will be limited to 14 starters. Horses not drawing a starting position in the gate will receive a refund of the entry fee. The guaranteed money to be distributed 60% to the the winner, 20% to second, 11% to third, 6% to fourth, 3% to fifth. A suitable award will be presented to the winning owner.
