Starters to pay \$525 additional with \$50,000 guaranteed by Remington Park and an additional \$20,000 included from the Oklahoma Bred Fund. Weights: Three-Year-Olds: 119 lbs; Older 124 lbs; Non winners of \$18,000 twice in 2020 allowed 2 lbs.; \$18,000 in 2020, 4 lbs.; \$15,000 in 2020, 6 lbs; (Maiden and Claiming Races not considered). Starters to be named through the entry box by the usual time of closing. High Weights Preferred. Total earnings in 2019-2020 will be used in determining the order of horses with equal weights on the scale. Earnings will be determined according to statistics provided by Equibase. This race will be limited to 12 starters. The guaranteed money and ÖBF funds to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. A suitable award will be presented to the winning owner.
