Weights: Three-year-olds 119 lbs.; Older 124 lbs. Non-winners of \$18,000 twice in 2020 allowed 2 lbs., \$18,000 once in 2020, 4 lbs., \$15,000 in 2020, 6 lbs.(Maiden and Claiming Races Not Considered). High Weights Preferred According To The Scale Of Weights, Then Preference to Total Highest Earnings 2019-2020 of Horses with Equal Weights on the scale. Earnings will be determined according to statistics provided by Equibase. This race will be limited to fourteen (14) starters. The guaranteed money and OBF funds to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. A suitable award will be presented to the winning owner.
