Weights: Three Years Old 119 lbs. Older 124 lbs. Non-winners of \$18,000 twice in 2021 allowed 2 lbs., \$18,000 once in 2021, 4 lbs., \$9,000 in 2021, 6 lbs. (Maiden and claiming races not considered). High Weights Preferred. Then Highest Lifetime Earnings Will Be Used In Determining The Order Of Preference Of Horses with Equal Weights on the Scale. Earnings will be determined according to statistics provided by Equibase. This race will be limited to 12 starters. The guaranteed money and OBF funds to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. A custom saddle towel will be presented to each entrant. A suitable award will be presented to the winning owner.
