High weights preferred. Then Preference to Highest Lifetime Earnings of Horses with Equal Weights. Lifetime Earnings will be determined according to statistics provided by Equibase. This race will be limited to twelve (12) starters. The guaranteed money and the OBF funds to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. A custom saddle towel will be presented to each entrant. A suitable award will be presented to the winning owner.
