Starters to pay \$530 additional with \$50,000 guaranteed by Remington Park and an additional \$20,000 included from the Oklahoma Bred Fund. Supplementary nominations may be made at time of entry for a fee of \$2,195, which qualifies to start. Weights: Three-Year-Olds: 119 lbs; Older 124 lbs; Non winners of \$18,000 twice in 2022 allowed 2 lbs.; Non Winners of \$18,000 in 2022 allowed 4 lbs.; Non Winners of \$15,000 in 2022 allowed 6 lbs; (Maiden and Claiming Races not considered). Starters to be named through the entry box by the usual time of closing. High Weights Preferred. Total earnings in 2021-2022 will be used in determining the order of horses with equal weights on the scale. Earnings will be determined according to statistics provided by Equibase. This race will be limited to 12 starters. The guaranteed money and OBF funds to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. A custom saddle towel will be presented to each entrant. A suitable award will be presented to the winning owner.
