Supplementary nominations may be made at time of entry for a fee of \$3,000, which qualifies to start. Starters to be named through the entry box by usual time of entry. Weights: Three-year-olds 119 lbs.; Older 124 lbs. Non-winners of \$30,000 twice at one mile or over on the turf in 2022 allowed 2 lbs.; Non-winners of \$30,000 once at one mile or over on the turf in 2022 allowed 4 lbs.; Non-winners of \$30,000 at any distance in 2022 allowed 6 lbs. (Maiden and Claiming Races not considered). High Weights Preferred According To The Scale Of Weights, Second Preference; Total Earnings in 2021-2022 For Horses with Equal Weights. Earnings will be determined according to statistics provided by Equibase. This race will be limited to 12 starters. The guaranteed money to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. A suitable award will be presented to the winning owner.
