FOR THREE- YEAR-OLD FILLIES No nomination fee. \$1,500 to pass the entry box. Starters to pay \$1,500 additional with \$200,000 guaranteed by Remington Park. Supplementary nominations may be made at time of entry at a fee of \$6,000, which qualifies to start. Starters to be named through the entry box by the usual time of entry. Weight: 122 lbs. Non-winners of \$50,000 twice at one mile or over in 2022 allowed 2 lbs.; Non-winners of \$50,000 once at a mile or over in 2022 allowed 4 lbs.; Non-winners of \$30,000 at any distance in 2022 allowed 6 lbs. (Maiden and Claiming races not considered). High weights Preferred, Horses with Equal Weights Preferred by Total Lifetime Earnings. Earnings will be determined according to statistics provided by Equibase. This race will be limited to 14 starters. The guaranteed money to be divided 60% to the winner, 20% to second, 11% to third, 6% to Fourth and 3% to Fifth. A suitable award will be presented to the winning owner.
