Supplementary nominations may be made at time of entry for a fee of \$2,195, which qualifies to start. Starters to be named through the entry box by usual time of entry. Weights: Three-year-olds 119 lbs.; Older 124 lbs. Non-winners of \$18,000 twice in 2021 allowed 2 lbs. Non-winners of \$18,000 once in 2022 allowed 4 lbs. Non-winners of \$15,000 in 2022 allowed 6 lbs. (Maiden and Claiming Races Not Considered). High Weights Preferred According To The Scale Of Weights, Then Preference to Total Highest Earnings 2021-2022 of Horses with Equal Weights on the scale. Earnings will be determined according to statistics provided by Equibase. This race will be limited to fourteen (14) starters. The guaranteed money and OBF funds to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. A custom saddle towel will be presented to each entrant. A suitable award will be presented to the winning owner.
