FOR THREE YEAR OLDS AND UPWARD. No Nomination fee. \$1,400 to pass the entry box and an additional \$1,400 to start with \$100,000 guaranteed. Supplementary nominations may be made at time of entry for a fee of \$4,800, which qualifies to start. Starters to be named through the entry box by the usual time of closing. Weights: Three-year-olds 119 lbs. Older 124 lbs. Non-winners of a Sweepstakes in 2023 allowed 2 lbs. Non-winners of \$30,000 at a mile or over twice in 2023 allowed 4 lbs. Non-winners of \$30,000 at a mile or over in 2023 allowed 6 lbs. (Maiden, Claiming, Starter races not considered in Allowances). High weights preferred. Preference of horses assigned equal weights to be determined by lifetime earnings. Earnings will be determined according to statistics provided by Equibase. This race will be limited to 14 starters. Horses not drawing a starting position in the gate will receive a refund of the entry fee.
