

Clever Trevor Stakes (BT) No Lasix Pursuant to HISA Regulations \$75,000 Guaranteed

(Plus \$7,500 From The Oklahoma Bred Program If Eligible)

FOR TWO YEARS OLD No nomination fee, \$750 to pass the entry box. Starters to pay \$750 additional with \$75,000 guaranteed. Supplementary nominations may be made at time of entry for a fee of \$3,000, which qualifies to start. Starters to be named through the entry box by the usual time of closing. Weights: 121 lbs.. Non-winners of a sweepstakes allowed 2 lbs., Non Winners of a race other than maiden or claiming 4 lbs., maidens 6 lbs. High weights on a scale preferred. Total earnings will be used in determining the order of preference of horses with equal weights on the scale. Earnings will be determined according to statistics provided by Equibase. This race will be limited to 12 starters. The guaranteed money to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. A suitable award will be presented to the winning owner.
