Non-winners of \$15,000 in 2023 allowed 6 lbs. High Weights Preferred According To The Scale Of Weights, Then Money Earned in 2022-2023 of Horses with Equal Weights (Maiden and Claiming races not considered in Allowances). Earnings will be determined according to statistics provided by Equibase. This race will be limited to twelve (12) starters. The guaranteed monies to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. A suitable award will be presented to the winning owner.
