(Plus \$30,000 From The Oklahoma Bred Program If Eligible)

FOR TWO-YEAR-OLDS No nomination fee. \$2,000 to pass the entry box. Starters to pay \$2,000 additional with \$300,000 Guaranteed. Supplementary nominations may be made at time of entry for a fee of \$8,000, which qualifies to start. Weights: 121 lbs.. First Preference to Stakes winning or stake-placed horses in graded/group stakes (in order I,II,III), then Preference to Lifetime Earnings. Lifetime Earnings will be determined according to statistics provided by Equibase. This race will be limited to twelve (12) starters. The guaranteed monies to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. The top three finishers in the Springboard Mile will get an automatic nomination to the Oklahoma Derby in 2024. The winner will receive an all fees paid entry into the Oklahoma Derby in 2024. Certain finishing positions in this race will earn points to qualify for the 2024 Kentucky Derby, pursuant to the official rules for the Road to the Kentucky Derby published by Churchill Downs Incorporated. A suitable award will be presented to the winning owner.
