FOR TWO-YEAR-OLD FILLIES No nomination fee. \$600 to pass the entry box. Starters to pay \$500 additional with \$50,000 guaranteed. Supplementary nominations may be made at time of entry for a fee of \$2,200, which qualifies to start. Weights: 121 lbs. Non winners of a sweepstakes allowed 2 lbs.; Non winners of a race other than maiden or claiming allowed 4 lbs.; maidens allowed 6 lbs. Starters to be named through the entry box by the usual time of entry. High Weights Preferred, then money earned for those horses with equal weights. Earnings will be determined according to statistics provided by Equibase. This race will be limited to 12 starters. The guaranteed money to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Fees include a custom saddle towel that will be presented to each entrant. A suitable award will be presented to the winning Owner.
