Non-winners of \$50,000 twice at one mile or over in 2024 allowed 2 lbs.; Non-winners of \$50,000 once at a mile or over in 2024 allowed 4 lbs.; Non-winners of \$30,000 at any distance in 2024 allowed 6 lbs. (Maiden and Claiming races not considered). High weights Preferred. Horses with Equal Weights Preferred by Total Lifetime Earnings. Earnings will be determined according to statistics provided by Equibase. This race will be limited to 14 starters. The guaranteed money to be divided 60% to the winner, 20% to second, 11% to third, 6% to Fourth and 3% to Fifth. A suitable award will be presented to the winning owner.
