FOR FILLIES AND MARES, THREE-YEAR-OLDS AND UPWARD No nomination fee. \$800 to pass the entry box. Starters to pay \$700 additional with \$75,000 guaranteed. Supplementary nominations may be made at time of entry for a fee of \$3,000, which qualifies to start. Starters to be named through the entry box at the usual time of entry. Weights: Three Years Old 118 lbs., Older 123 lbs. Non-winners of \$18,000 twice at a mile or over on the turf in 2024 allowed 2 lbs., Non-winners of \$18,000 once at one mile or over on the turf in 2024 allowed 4 lbs., Non-winners of \$15,000 at any distance in 2024 allowed 6 lbs. (Maiden and claiming races not considered in weight allowances). High Weights Preferred on the Scale, Then Highest Earnings 2023-2024 for horses with equal weights on the scale. Earnings will be determined according to statistics provided by Equibase. This race will be limited to 12 starters. The guaranteed money to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Fees include a custom saddle towel that will be presented to each entrant. A suitable award will be presented to the winning owner.
