FOR FILLIES AND MARES THREE-YEAR-OLDS AND UPWARD ACCREDITED OKLAHOMA FOALS. No nomination fee. \$600 to pass the entry box. Starters to pay \$500 additional with \$50,000 guaranteed by Remington Park and an additional \$20,000 plus from the Oklahoma Bred Fund. Supplementary nomination may be made at time of entry for a fee of \$2,200, which qualifies to start. Starters to be named through the entry box by usual time of entry. Weights: Three-year-olds 118 lbs.; Older 123 lbs. Non-winners of \$15,000 twice in 2026 allowed 2 lbs., Non Winners of \$18,000 once in 2026 allowed 4 lbs., Non Winners of \$15,000 in 2026 allowed 6 lbs. (Maiden and Claiming Races Not Considered). High Weights Preferred According To The Scale Of Weights, Then Highest Earnings in 2025-2026 of horses with equal weights on the scale. Earnings will be determined according to statistics provided by Equibase. This race will be limited to 12 starters. The guaranteed money and OBF funds to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Fees include a custom saddle towel that will be presented to each entrant. A suitable award will be presented to the winning owner.
